DANGEROUS DRUGS

ACTOS: Diagnosed bladder cancer.

GRANUFLO/NATURALYTE: Heart arrhythmias, heart attacks, strokes, and sudden death within 48 hours of dialysis treatment.

JANUVIA/BYETTA/JANUMET/VICTOZA: Diagnosed with Pancreatic Cancer or Thyroid Cancer.

LIPITOR: Women diagnosed with diabetes with a BMI under 32.

PRADAXA/ XARELTO: Causes life-threatening internal bleeding and other health complications. No antidote, cannot be reversed if overdosed.

RISPERDAL: Adolescent males diagnosed with Gynecomastia, (male breasts) under the age of 25.

SSRI'S (ZOLOFT, PROZAC, PAXIL, LEXAPRO, EFFEXOR): Birth defects in children of women taking these drugs while pregnant.

TYLENOL: Diagnosed liver disease.

VIAGRA: Development of Melanoma.

YAZ/NUVARING: DVT (Deep Venous Thrombosis) or Blood Clots.
